- The Section must receive a Bio and/or Resume for each speaker.
- The use of company names and logos within a presentation must be kept to the introduction only and not used throughout the presentation.
- Presenters with proprietary interest of any kind agree not to advertise, promote, endorse or market their interest during their presentation at any time.
- The section must receive a copy of your presentation and handouts that will be used during the presentation prior to the conference. With your agreement, the Section will prepare a CD of all presentations for conference participants.
- The section reserves the right to cancel and/ or request a change to a presentation based on content submitted.
